I would like to just ask a few questions in relation to the above call for bids, more particularly page 35 on the pricing schedule.   - The consultant would be expected to identify the required training, trainers in the province and assist in the logistical arrangements. We envisage that this activity would take time and hence require this time to be costed.
  - This links to the point above. We envisage setting up 10 container hair and beauty salons. Whilst the container will be designed by the consultant a key element of the role is to confirm the establishment/setting up of these containers to ensure they are fit for purpose. Again, we assume this would incur costs.

- 2. Item 7: "Identify and arrange accredited technical trade tests and related training for the Hair Industry for 20 beneficiaries. (ECDC to source training directly)". Can I leave that blank? Seeing that ECDC would be sourcing it.
- 3. Item 6: "Ensure that the purchased containers with its furniture, fittings and equipment is delivered, installed and commissioned accordingly in order to commence operations". The architects and I feel that we need more clarity on this as the quantity says 10. As this can also be covered under item 3 with the bill of quantities.
